INSTRUCTIONS FOR FULTON COUNTY DOG LICENSES:

1. Complete the form. Be sure the correct street number, street name, and pet descriptions(s) appear on all applications.
2. Use this form to register one to five dogs. If you have more than five dogs, please print additional forms. Ohio law requires a license for every dog more than 3 months old.
3. Return this for your 2010 license tag(s) **Before January 31**, enclose a check or money order for **\$20.00 per dog** payable to: Fulton County Auditor. *Please do not send cash.*
4. **After January 31**, the statutory late penalty increases the fee to **\$40.00 per dog**. Your application cannot be processed until the correct fees are received. Please apply early.
5. Insert check or money order and the application, affix the correct postage, and mail early.
6. Please enclose a self addressed stamped envelope.

At the request of the Fulton County District Board of Health, this form requires information relating to your dog's rabies vaccination. The District Board of Health has adopted a regulation requiring all dogs be immunized against rabies. Please indicate the expiration date of the rabies vaccination, the veterinarian, and rabies tag number.

If you prefer, you may purchase the tag in person at the Fulton County Auditor's Office, 152 S. Fulton Street, Suite 165, Wauseon, Monday - Friday, 8:30 a.m. to 4:30 p.m.
