

RESOLUTION 2008-106

In the Matter of Resolution Awarding Bid) Office of County Commissioners,
for 2008 Construction Materials - Concrete) Fulton County, Ohio

The Board of County Commissioners of Fulton County, Ohio met in regular session pursuant to notice, on February 8, 2008, at 152 South Fulton Street, Wauseon, Ohio, with the following members present:

Commissioner Short moved for the adoption of the following resolution:

WHEREAS, bids were received on January 28, 2008 for 2008 Construction Materials - Concrete Pipe and Aggregate for the Fulton County Engineer, and

WHEREAS, after reviewing the bids, and with the recommendation of the Fulton County Engineer, Frank T. Onweller, it was recommended to accept all unit price bids received by the various vendors for the 2008 Construction Materials - Concrete Pipe and Aggregate, and

WHEREAS, the Fulton County Engineer has recommended that purchases be made through purchase orders and by the unit price of the material, the location of the job site, the type of gradation of the materials required, the compatibility of the products, the quality of the material and the availability,

THEREFORE, BE IT RESOLVED, that the award of bid for the 2008 Construction Materials – Concrete Pipe and Aggregate to be used by the Fulton County Engineer be given to Independent Concrete Pipe; Chris Rorick Trucking LLC; Gerken Materials; The Custar Stone Co.; Hanson Aggregate Midwest Inc.; Viking Trucking Co.; Kuhlman Corp.; Tim Rice Trucking, LLC; and The Shelly Co./Stoneco Inc.; purchases to be made by the unit price of the material, the location of the job site, the type of gradation of the materials required, the compatibility of the products, the quality of the material, and the availability.

BE IT FURTHER RESOLVED, that ultimate purchases be made through purchase orders.

BE IT FURTHER RESOLVED that it is found and determined that all formal actions of this Board of County Commissioners, County of Fulton, State of Ohio concerning the adoption of this resolution were adopted in an open meeting of this Board of County Commissioners, and that all deliberations of this Board of County Commissioners and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
