

**RESOLUTION 2008-296**

In the Matter of Resolution Awarding Bid ) Office of County Commissioners,  
For Bridge Replacement 1.1F.4 Project ) Fulton County, Ohio

The Board of County Commissioners of Fulton County, Ohio met in regular session pursuant to notice, on April 3, 2008 at 152 South Fulton Street, Wauseon, Ohio, with the following members present:

Commissioner Barnaby moved for the adoption of the following resolution:

**WHEREAS,** bids were received on March 27, 2008 for the Replacement of Bridge 1.1F.4 project for the Fulton County Engineer, and

**WHEREAS,** after reviewing the bids, and with the recommendation of the Fulton County Engineer, Frank T. Onweller, it was determined that R.G. Zachrich Construction Inc. of Defiance, Ohio submitted the lowest and best bid at \$723,126.61. This amount is below the engineer's estimate of \$812,704.25;

**THEREFORE, BE IT RESOLVED,** that the award of bid for the Replacement of Bridge 1.1F.4 project for the Fulton County Engineer be awarded to R.G. Zachrich Construction Inc. of Defiance, Ohio in the amount of \$723,126.61. A contract will be offered for the project.

**BE IT FURTHER RESOLVED,** that it is found and determined that all formal actions of this Board of County Commissioners, County of Fulton, State of Ohio concerning the adoption of this resolution were adopted in an open meeting of this Board of County Commissioners, and that all deliberations of this Board of County Commissioners and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
