This Single County Ditch petition was filed February 24, 2022. In the watershed there are about 30-40 acres drained with 98% being residential and 2% public r/w. The objectives of this project are to remove standing water, provide improved capacity to outlet, and put this on a permanent maintenance program. The work plan is to install a 12in sealed pipe from the open ditch to road 1-2 and to install a 10in and 8in sealed pipe along road 1-2. We would also install catch basins and yard drains, repair drives, and repair lawns and roadside. We are looking at a Construction Cost of \$116,926.69, an Engineers Cost of \$7,015.60, a Clerks Cost of \$500.00 giving us a total project cost \$124,442.29. For the benefit determination it has been calculated that a 20 year agricultural benefit is \$2,118 per acre, the 20 year residential benefit is \$550.00 per acre, and the overall 20 year project benefit is \$330,000.00.
