OSU Extension Staff- Departmental Updates

Melissa Rupp started by thanking the Commissioner for their ongoing support. It has been a busy 6 months with having 6 schools participate in the Real Money Real World, 9 classes held for preservation and food safety. There were 1143 youth and adults that received direct SNAP- ED nutrition education. Some of the highlights were 9 area food service establishments became ODH food safety compliant, 23 FCS high school teacher received 6 hours of professional development and 403 high school students learned financial skills through Real Money Real World. As educators Melissa and Sara received the 2022 Compass Award from the Ohio Treasurers Office. Commissioner Jon Rupp asked about the SNAP program and if this is something that OSU works with JFS on. Melissa said that they have Jodi in their office that is the SNAP-ED educator and she does work with JFS. Commissioner Jeff asked Melissa about what happens if the food establishments do not pass the test and qualify to become ODH compliant. Melissa said that they had a couple that didn't pass and they either have to come back and try again or send someone else to come take the test.

Eric Richer stated that since Feb 2022 the activities that they held were Farm Management Series, Fertilizer/Pesticide Recert, and a Corn N Management Talk. This time of year is heavy field work where Eric currently has 8 eFields on farm research trials in Fulton County for Tar Spot in corn, soil health/cover crops. Eric has Co-authored the 2022 Ohio Farm Custom Rates fact sheet which is a really helpful tool to farmers. Some of the newsworthy items that have happened or will be happening is Breakfast on the Farm hosted by Triple H Farms in Metamora and the date is TBA, Courtney Krieger was hired as Water Quality Extension Associate, and finally we hosted the National Waste to Worth Conference which is for organic nutrient practitioners.

Sara Lewis has started her second full summer with Fulton County. We are up in the number of members with 791 4-H members and 34 4-H clubs. We finished up 4-H camp 2 weeks ago and we had 135 participants with 41 being first time campers. Sara has recently traveled with 19 youth to Washington DC for CWF. Commissioner Jon asked what they age group was on the 19 students. Sara stated they ranged from 14-18 years old. Sara attended the NECV in Tulsa, OK which was very informative and gave great tools and resources to help with the current 159 4-H volunteers.
