There were changes made to the tax settlement which is due to the rollback of the 1 mill we did that is why there is a significant difference. In the other receipts line there was an increase from \$24,000 to \$50,000 due to our contract with Henry County which we never know until the fall if we are going to have it which we now have it. Beth added the transfer in line to \$45,000 which is for Soil and Water.</p> <p>On the expense side we have done some different things with employees. We have added a couple of people and are looking at the possibility of adding another person next year. The next big thing is the HCBS Waiver Local Match Residential. That went from \$1,083,181 to \$50,000 due to it being taken out of somewhere else. The reserve balance account is the one that can have 40% of the previous year's expenses in it.
