He advised that he received a quote from Granger also but they were about \$500 more for the same product.</p> <p>He explained that each department would have a key for their own slot. The mail carrier will have a main key that will open all of them at once. The price quoted is for a box mounted on a pedestal. This is being recommended as opposed to a wall mount due to the weight of the box. He explained that currently the post office will no longer deliver to the offices in the Plaza until a box is put in. He believes the departments are going to the post office to collect their mail in the meantime. He spoke with the postmaster this morning and was advised that this model would meet their standards. They are also amenable to the box being placed inside of the building in the lobby area.</p> <p>Commissioner Barnaby made the motion and Commissioner Rufenacht seconded the motion.
