Factors which will determine ultimate purchases by Fulton County are; unit bid prices, terms of purchase, location of project, availability of gradation, type of material desired for a particular application, quality of product, type of surface desired. If available, prices are requested for washed #8 stone and 25A (Michigan) stone.

Aggregate for projects that require large quantities will be priced at the time of construction by price quotations requested from the bidders.
