

**BOND SCHEDULE  
EFFECTIVE JULY 1, 2021**

Pursuant to Crim.R. 46(G), the bail schedule for misdemeanor charges, including traffic offenses, unless excluded below, shall be set as follows:

1. A rebuttable presumption of personal recognizance (O.R.) is the rule.

If the police officer or prosecutor, based on the circumstances of the case, has reasonable cause to believe that a personal recognizance bond is insufficient, the judge or magistrate shall be contacted for additional authority. If the judge or magistrate determines that the personal bail is insufficient, the conditions of release shall be set pursuant to Crim.R. 46.

When a judge or magistrate has previous set bail in a case, or has ordered a new amount in its last capias or warrant entry, that bail shall remain in effect unless otherwise ordered by a judge or magistrate.

For all other charges, the judge or magistrate of the court shall set bail pursuant to Crim.R. 46.

2. **NO BOND: VIOLATING T.P.O. and**

**Any "offense of violence" as defined in Section 2901.01(A)(9), Ohio Revised Code, except "menacing" pursuant to Section 2903.22, ORC, and "child endangerment" 2919.22, ORC. (See attached Exhibit "A")**
