NOTICE TO BIDDERS

PROPOSAL

It is the purpose of this Proposal to obtain HOURLY RATE BIDS for labor and equipment commonly used in the performance of COUNTY DITCH MAINTENANCE activities to be completed in Fulton County, Ohio during the 2023 calendar year.

County Ditch Maintenance activities in Fulton County include:

- Brush Removal and Disposal
 - o Ditch bank and berm mowing
 - o Mechanical brush cutting and shearing
 - o Clearing and grubbing brush
 - o Hand cutting brush
 - o Brush spraying; foliar spray and cut surface treatment
 - o Removal of log jams, down trees, drift and debris
 - o Brush and tree disposal including hauling, grinding and/or burning
- Channel Work
 - o Channel bottom sediment clean out
 - o Spoil leveling
 - o Spoil hauling
 - o Bank shaping
 - o Mechanical rip rap placement
 - o Mechanical rock picking
 - o Hand placing rip rap and rock picking
- Seeding and Restoration
 - o Seed bed preparation
 - o Seeding and fertilizing banks
 - o Seeding and fertilizing berms
 - o Seeding, fertilizing and mulching roadsides and lawns
- Tile Work and Drainage Structures
 - o Tile line locating
 - o Camera inspection

BID FORM

Bids shall be made on the attached Bid Form or by attachments hereto by the Bidder in whatever form they choose, conditioned that it shall be submitted in ink, typed or printed form and shall include any and all terms of purchase.

The Bidder should sign the Contract Form and complete and return the following with the bid:

Non-Collusion Affidavit

Personal Property Tax Affidavit

Non-Discrimination Affidavit

No Findings for Recovery Affidavit

The bid must be filed in a sealed envelope on or before the time given in the advertisement and at the location stated in the Legal Notice. Bids will be opened at the time stated in the notice. Each bid must contain the full name of each person or company submitting the bid.

CONTRACTOR SELECTION

Contractor selection for a particular project will be based upon the following criteria:

- The nature and extent of the requested ditch maintenance work plan
- The recommendation or contractor preference of the requesting landowner
- The equipment available to the contractor to efficiently complete the work plan
- The availability of the contractor to complete the work plan within the allotted construction timeframe
- The rates quoted by the contractor for the labor and equipment needed to complete the maintenance work plan and any terms of purchase
- Demonstrated skills and expertise in completing the work items and in dealing with landowners

INSURANCE

Prior to entering into the contract, the successful bidder must provide Fulton County with a Certificate of Insurance, indicating that he has in force a *minimum of \$1,000,000.00 in liability insurance and proof of coverage by Worker's Compensation Insurance* before a contract can be awarded. While not required, it will expedite the contract award process if the required insurance documents are submitted with the bid.

EQUAL CONSIDERATION

All bidders must be willing to enter into a *construction contract* in which they agree and assent, as part of the general terms and conditions of that contract, to the statutory requirements contained in Section 153.59 of the Ohio Revised Code, which requires the following:

Every contract for or on behalf of the state, or any township, county, or municipal corporation of the state, for the construction, alteration, or repair of any public building or public work in the state shall contain provisions by which the contractor agrees to both of the following:

(A) That, in the hiring of employees for the performance of work under the contract or any subcontract, no contractor, subcontractor, or any person acting on a contractor's or subcontractor's behalf, by reason of race, creed, sex, disability or military status as defined in section 4112.01 of the Revised Code, or color, shall discriminate against any citizen of the state in the employment of labor or workers who is qualified and available to perform the work to which the employment relates;

(B) That no contractor, subcontractor, or any person on a contractor's or subcontractor's behalf, in any manner, shall discriminate against or intimidate any employee hired for the performance of work under the contract on account of race, creed, sex, disability or military status as defined in section 4112.01 of the Revised Code, or color.

The department of administrative services shall ensure that no capital moneys appropriated by the general assembly for any purpose shall be expended unless the project for which those moneys are appropriated provides for an affirmative action program for the employment and effective utilization of disadvantaged persons whose disadvantage may arise from cultural, racial, or ethnic background, or other similar cause, including, but not limited to, race, religion, sex, disability or military status as defined in section 4112.01 of the Revised Code, national origin, or ancestry.

In awarding contracts for capital improvement projects, the department shall ensure that equal consideration be given to contractors, subcontractors, or joint ventures who qualify as a minority business enterprise. As used in this section, "minority business enterprise" means a business enterprise that is owned or controlled by one or more socially or economically disadvantaged persons who are residents of this state. "Socially or economically disadvantaged persons" means persons, regardless of marital status, who are members of groups whose disadvantage may arise from discrimination on the basis of race, religion, sex, disability or military status as defined in section 4112.01 of the Revised Code, national origin, ancestry, or other similar cause.
