The Board of County Commissioners of Fulton County, Ohio, met in regular session pursuant to notice, on March 16, 2023, at 152 S. Fulton St., Wauseon, Ohio, with the following members present:

Commissioner Jon Rupp moved for the adoption of the following resolution:

WHEREAS, bids were received on February 23, 2023 for the Resurfacing of Road 5-2 and Gorham Township Road S on behalf of the Fulton County Engineer; and

WHEREAS, on February 28, 2023, upon the recommendation of the Fulton County Engineer, the bid was awarded to Gerken Paving, Inc. in the amount of \$1,931,000.00 and a contract facilitating the project has been successfully negotiated; and

THEREFORE BE IT RESOLVED, that the Board of Fulton County Commissioners enters into Contract 2023-66 with Gerken Paving, Inc., for the Resurfacing of Road 5-2 & Gorham Township Road S in the amount of \$1,931,000.00, subject to the terms and conditions therein; and

BE IT FURTHER RESOLVED, that it is found and determined that all formal actions of this Board of County Commissioners, County of Fulton, State of Ohio concerning the adoption of this resolution were adopted in an open meeting of this Board of County Commissioners, and that all deliberations of this Board of County Commissioners and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

CONTRACT NO. 2023-66

This Contract, made this 16th day of March A.D. 2023 between the BOARD OF FULTON COUNTY COMMISSIONERS hereinafter called "Board" and GERKEN PAVING, INC., hereinafter called "Contractor".

WITNESSETH: That for and in consideration of payments hereinafter mentioned, to be made by the Board, Contractor agrees to furnish all materials, equipment, tools and labor necessary to perform all the work required for

Resurfacing of County Road 5-2, German Township Road 24, and Gorham Township Road S

According to the plans and specifications and to the satisfaction and acceptance of the Board, as well as complying with all applicable federal, state, and local laws in the conduct of work performed hereunder.

The Contractor further covenants and agrees that the following papers shall be an essential and binding part of this contract: Notice to contractors, plans and specifications, contract, contract bond, and proposal.

Partial payments shall be made in accordance with the Ohio Revised Code. The Contractor shall submit a schedule of the work completed to the Engineer for approval. Payments shall be at the rate of 92% of the acceptable work completed until the project is 50% completed. After the project is 50% complete payments shall be made at the rate of 100% of the amount of acceptable work completed.

All work shall be completed in its entirety and equipment removed by August 9, 2023. Liquidated damages will be deducted for work not completed by the completion date as per the Ohio Department of Transportation Standard Specifications.

In consideration of the premises the Board agrees to pay to Contractor the appropriate sum of one million, seven hundred ninety thousand, seven hundred fourteen dollars and 18/100 (\$1,790,714.18). The actual sum to be paid, however, will be determined by the amount of work actually completed and calculated by the unit price set out in the proposal.
