

PROCLAMATION

NOTICE OF SPECIAL ELECTION (R.C. 3501.03)

The Board of Elections of Fulton County, Ohio, issues this Proclamation and Notice of Election.

A SPECIAL ELECTION WILL BE HELD ON
TUESDAY, the 6th day of AUGUST, 2013,
(being the first Tuesday after the first Monday in August)

At the usual place of holding elections in the Swanton Local School District* in FULTON COUNTY or at such places as the Board may designate for the purpose of determining the following questions and issues:

1	<p>Proposed Bond Issue and Tax Levy Swanton Local School District – Fulton and Lucas Counties</p> <p>A majority affirmative vote is necessary for passage.</p> <p>Shall the Swanton Local School District be authorized to do the following:</p> <p>(1) Issue bonds for the purpose of constructing, renovating, remodeling, enlarging, furnishing, equipping and otherwise improving School District buildings and facilities and acquiring, clearing, equipping and otherwise improving School District building and facility sites in the principal amount of \$13,499,000, to be repaid annually over a maximum period of 35 years, and levy a property tax outside the ten-mill limitation, estimated by the county auditor to average over the bond repayment period 3.9 mills for each one dollar of tax valuation, which amounts to 39 cents for each one hundred dollars of tax valuation, to pay the annual debt charges on the bonds, and to pay debt charges on any notes issued in anticipation of those bonds?</p> <p>(2) Levy an additional property tax to provide funds for the acquisition, construction, enlargement, renovation, and financing of general permanent improvements at a rate not exceeding 0.5 mill for each one dollar of tax valuation, which amounts to 5 cents for each one hundred dollars of tax valuation, for a continuing period of time?</p>	Swanton Local School District (13-2, 23,24,25,26,27,28-1)
