

**NOTICE OF ELECTION ON A BOND ISSUE AND A TAX LEVY FOR
THE SWANTON LOCAL SCHOOL DISTRICT**

Notice is given that pursuant to resolutions adopted by the Board of Education of the Swanton Local School District, Fulton and Lucas Counties, Ohio, on May 1, 2013 and May 7, 2013, there will be submitted to a vote of the electors of that School District at an election to be held therein on August 6, 2013, at the regular places of voting therein*, the following questions as a single proposal:

1. The question of the issuance of bonds by the School District for the purpose of constructing, renovating, remodeling, enlarging, furnishing, equipping and otherwise improving School District buildings and facilities and acquiring, clearing, equipping and otherwise improving School District building and facility sites, in the principal amount of \$13,499,000, to be repaid annually over a maximum period of 35 years, and an annual levy of property taxes to be made outside the ten-mill limitation, estimated by the county auditor to average over the repayment period of the bond issue 3.90 mills for each one dollar of tax valuation, which amounts to 39 cents for each one hundred dollars of tax valuation, to pay the annual debt charges on the bonds and to pay debt charges on any notes issued in anticipation of the bonds; and

2. The question of an additional property tax levy for the benefit of the School District at the rate of 0.5 mill for each one dollar of valuation, which amounts to 5 cents for each one hundred dollars of tax valuation, to provide funds to pay costs of the acquisition, construction, enlargement, renovation, and financing of general permanent improvements, for a continuing period of time.

If a majority of the voters voting on the single proposal of the bond issue and the tax levy vote in favor thereof, the taxes for debt charges and permanent improvements are expected to be first placed on the tax list and duplicate in December 2013 for first collection in calendar year 2014.

The polls for that election will be open at 6:30 a.m., and will remain open until 7:30 p.m., of that day.
