It is the purpose of this Proposal to obtain unit price bids for Concrete Pipe meeting ODOT Specifications 706.01 and 706.02, to be used in the 2016 Fulton County Highway Construction and Maintenance Program.

Proposals may be obtained or examined at the office of Frank T. Onweller, Fulton County Engineer, 9120-14, Wauseon, Ohio.

By a unanimous vote of the Board of Fulton County Commissioners, all of the requirements of Section 153.54 of the Revised Code have been waived for these bids.

The bidders are requested to submit unit price bids for the various sizes of concrete pipe commonly used in highway construction programs and those commonly manufactured and/or made available for purchase f.o.b. their respective companies. Unit bid prices are to include delivery to any point in Fulton County.

Factors which will determine ultimate purchases by Fulton County are: unit bid prices, location of project, type of material desired for a particular program, quality of material, availability of material and available funding. Quantities of purchase, and sizes and types of pipe purchased will be at the option of Fulton County.

Pipe for projects that require large quantities, will be priced at the time of construction by price quotations requested from the bidders.
