WHEREAS, bids were received on March 28, 2017 for the 2017 Bridge 25D.2 project on behalf of the County Engineer; and

WHEREAS, on March 30, 2017, pursuant to the recommendation of the County Engineer, the Commissioners awarded the bid to Miller Brothers Construction, Inc. in the amount of \$305,255.50; and

THEREFORE, BE IT RESOLVED, the Fulton County Board of Commissioners does hereby enter into Contract 2017-39 with Miller Brothers Construction, Inc. for the 2017 Bridge 25D.2 project as attached hereto; and

BE IT FURTHER RESOLVED, that it is found and determined that all formal actions of this Board of County Commissioners, County of Fulton, State of Ohio concerning the adoption of this resolution were adopted in an open meeting of this Board of County Commissioners, and that all deliberations of this Board of County Commissioners and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

CONTRACT NO. 2017-39

This Contract, made this 6th day of April A.D. 2017 between the BOARD OF FULTON COUNTY COMMISSIONERS hereinafter called "Board" and Miller Bros. Const., Inc. hereinafter called "Contractor".

WITNESSETH: That for and in consideration of payments hereinafter mentioned, to be made by the Board, Contractor agrees to furnish all materials, equipment, tools and labor necessary to perform all the work required for

BRIDGE 25D.2 REPLACEMENT

According to the plans and specifications and to the satisfaction and acceptance of the Board, as well as complying with all applicable federal, state, and local laws in the conduct of work performed hereunder.

The Contractor further covenants and agrees that the following papers shall be an essential and binding part of this contract: Notice to contractors, plans and specifications, contract, contract bond, and proposal.

Partial payments shall be made in accordance with the Ohio Revised Code. The Contractor shall submit a schedule of the work completed to the Engineer for approval. Payments shall be at the rate of 92% of the acceptable work completed until the project is 50% completed. After the project is 50% complete payments shall be made at the rate of 100% of the amount of acceptable work completed.

All work shall be completed in its entirety and equipment removed by August 25, 2017. Liquidated damages will be deducted for work not completed by the completion date as per the Ohio Department of Transportation Standard Specifications.

In consideration of the premises the Board agrees to pay to Contractor the appropriate sum of three hundred five thousand, two hundred fifty-five dollars and 50/100 (\$305,255.50). The actual sum to be paid, however, will be determined by the amount of work actually completed and calculated by the unit price set out in the proposal.
