WHEREAS, bids were received on May 31, 2012 for the 2012/2013 Rock Salt for Ice Control Project on behalf of the Fulton County Engineer; and

WHEREAS, after review of the bids by the Frank Onweller, County Engineer, he recommended that the contract be awarded to the low unit price bidder for delivery by truck to the North American Salt Co., A Compass Minerals Co., of Overland Park, Kansas, as submitted in the amount of \$61.43 per ton; and

THEREFORE, BE IT RESOLVED, the Fulton County Board of Commissioners accepts the Engineer's recommendation and hereby awards the bid for the 2012/2013 Rock Salt for Ice Control Project to the North American Salt Co., A Compass Minerals Co., of Overland Park, Kansas, in the amount of \$61.43 per ton for delivery by truck. A contract will be offered for the project; and

BE IT FURTHER RESOLVED, that it is found and determined that all formal actions of this Board of County Commissioners, County of Fulton, State of Ohio concerning the adoption of this resolution were adopted in an open meeting of this Board of County Commissioners, and that all deliberations of this Board of County Commissioners and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

We have reviewed the three bids submitted for supplying the County with rock salt for ice control operations during the 2012-2013 winter season. Please note, two other suppliers responded to the bid advertisement indicating they were unable to submit a bid at this time but to keep them on the bidders list for next year. We recommend that the contract be awarded to the low unit price bidder for delivery by truck – North American Salt Co., A Compass Minerals Co., 9900 W. 109th St., Suite 100, Overland Park, KS 66210.

The unit price submitted was \$61.43 per ton. For comparison, last year we paid \$63.59 per ton.
