Issue 1 Rights for Crime Victims – Proposed Constitutional Amendment – Proposed by Initiative Petition
Issue 2 To require state agencies to not pay more for prescription drugs that the Federal Department of Veterans Affairs and require state payment of attorney fees and expenses to specific individuals for defense of the law – Proposed Law – Proposed by Initiative Petition
3. Fulton County – Renewal 0.7 mill and increase of 0.3 mill for 9-1-1 System for 5 years
4. Village of Lyons – Renewal 4.1 mills for Current Operating Expenses for 5 years
5. Village of Lyons – Renewal 0.5 mill for Parks and Recreation for 5 years
6. Amboy Township – Renewal 1 mill for Fire and Rescue Services for 5 years
7. Chesterfield Township – Renewal 0.7 mill for Fire Protection and EMS for 5 years
8. Fulton Township – Replacement 0.75 mill for Fire and Rescue for 5 years
9. German Township – Additional 2 mills for Fire equipment and related fire expenses for 5 years
10. Pike Township – Replacement 0.5 mill for Fire Protection and EMS Services for 5 years
11. Archbold Community Library – Additional 1.2 mills for Current Expenses for 5 years
12. Evergreen Local School District – Income Tax Renewal with Reduction 0.25% 1-1-2018
13. Fayette Local School District – Renewal 7 mills for Current Operating Expenses for 5 years
14. Swanton Two Precinct – Local Option – Sunday Sales of spirituous liquor between 11am and midnight

The polls for the election will open at 6:30 a.m. and remain open until 7:30 p.m. on Election Day.
